

INDEMNITY AND HOLD HARMLESS AGREEMENT

GEORGIA, COLQUITT COUNTY

As partial consideration of the services undertaken by Sunbelt Agricultural Exposition, Inc., (hereinafter referred to as "Sunbelt") related to the Southeast Sunbelt Agricultural Exposition (hereinafter referred to as "Exposition") located in Colquitt County, Georgia, the undersigned exhibitor (hereinafter referred to as ("Exhibitor")) does hereby indemnify and agrees to hold harmless Sunbelt, its successors, assigns, officers, directors, employees, and agents, from and against any and all liability, loss, damage, expense, lawsuit, foreclosure, repossession, attorney's fees, court costs, and any other costs of litigation or expenses which may arise for any reason out of the undersigned Exhibitor's delivery, maintenance, housing, operating, or showing any equipment or property at the 2010 Exposition for a period of six (6) years thereafter at any subsequent Exposition to be held at Spence Field in Colquitt County, Georgia, or at such other locations in Colquitt County, Georgia. Exhibitor agrees that Sunbelt accepts no liability for loss or damage to any property of Exhibitor that is cosigned to Sunbelt or left for display or use at any Exposition. Exhibitor further acknowledges and agrees to provide its own causality insurance should something happen to its property or equipment, including sufficient insurance to cover any loss for storage or delivery to the Exposition. Exhibitor further agrees to keep and maintain liability insurance on its equipment and property in a sufficient amount to protect itself and Sunbelt from any claims or damages that any person may have as a result of any claim that said injured party may have for injuries or damages sustained related to the equipment or property of Exhibitor.

Exhibitor understands and agrees that Sunbelt shall not be responsible in any way for any damage or destruction to Exhibitor's property, nor shall it be reliable or responsible for any damages to any person or property of another that is damaged or injured by the equipment or property of Exhibitor; and Exhibitor shall indemnify and hold Sunbelt harmless from any such claim or damage by any party whatsoever.
